## Industrial Mechanical Technician

Mobility/Motor Skills	<ul> <li>Ability to demonstrate fine and gross motor skills and coordination for the purposes of safely completing a multitude of job tasks.</li> <li>Ability to operate industrial machinery, power tools, hand tools, welding equipment, and cutting tools for the purpose of operating safely and properly in industrial / manufacturing environments.</li> <li>Possess the physical and mental stamina to meet the demands associated with extended periods of standing, moving, and physical exertion required for operation of tools and machines in the performance of maintenance tasks.</li> </ul>	<ul> <li>Understanding the connection between our manual manipulations and the tasks we are performing.</li> <li>Lift, hold, and operate various power tools for greater than 60 seconds.</li> </ul>
Tactile Skills	Ability to sense vibrations through touch.	<ul> <li>Feeling and interpreting vibrations.</li> </ul>

Auditory Skills	<ul> <li>Ability to tolerate a wide range of loud noises.</li> <li>Ability to effectively hear sounds that indicate potential issues and problems in the industrial / manufacturing environment.</li> <li>Ability to utilize auditory feedback in the troubleshooting of machine and system problems.</li> </ul>	<ul> <li>Wearing hearing protection.</li> <li>Listening and asking questions when necessary to clarify what you have heard.</li> </ul>	
Visual Skills	<ul> <li>Possess sufficient visual acuity to distinguish details from a distance and at a close proximity while wearing appropriate eye protection.</li> <li>Possess sufficient vision to access printed and electronic documents as well as, hardware type and electronic reading measurement tools and gauges.</li> <li>Ability to distinguish colors when working with electrical equipment.</li> </ul>	<ul> <li>Focusing while looking.</li> <li>Protecting your eyes with appropriate PPE.</li> </ul>	
Communication Skills	<ul> <li>Ability to follow both written and verbal instructions.</li> <li>Ability to have appropriate interpersonal interactions with other students, faculty, staff, facility owners, customers, and other technicians when providing and receiving information.</li> <li>Ability to effectively communicate with others, whether written or verbal.</li> <li>Ability to focus while listening for the purpose of receiving instruction and information in the troubleshooting process.</li> <li>Ability to use appropriate technology to communicate when necessary.</li> <li>Ability to formulate and communicate questions.</li> <li>Ability to effectively communicate in loud and high vibration environments.</li> </ul>	<ul> <li>Listening is crucial to good communication.</li> <li>Using complete sentences to express thoughts.</li> <li>Using software to communicate data and information.</li> </ul>
