Communication Skills	<ul> <li>Ability to effectively express oneself in English in verbal, nonverbal, and written formats with faculty, students, patients, and families, and other healthcare team members.</li> <li>Ability to read, identify, and chart data as needed.</li> <li>Ability to understand charts, graphs, and worksheets.</li> <li>Ability to interact with patients, family, and medical staff in a timely and professional manner.</li> <li>Ability to follow proper phone protocol.</li> <li>Ability to speak, write, and understand English.</li> </ul>	<ul> <li>Satisfactory speaking, reading and writing skills to effectively communicate in English.</li> <li>Maintain clear, concise and accurate laboratory records and reports.</li> </ul>

- Ability to utilize personal protective equipment.
- Ability to operate lab equipment, adhering to lab safety standards.
- · Ability to maintain confidentiality.
- Ability to adhere to attendance, dress code, and personal hygiene protocol.
- Ability to accept accountability.
- Ability to display integrity, honesty, and responsibility.
- Ability to comply with legal and ethical standards of the medical profession, and policies of the phlebotomy program.
- Ability to demonstrate appropriate impulse control and professional level of maturity.
- Ability to handle demanding clinical assignments and handle the stress that goes with it.
- Ability to demonstrate calm and effective behavior and responses, especially during emergency situations.

- Time management of multiple priorities, multiple stimuli in fastpaced environments.
- Calmly react to urgent situations.
- Satisfactory intellectual, emotional, and psychological health and functioning to ensure patient safety and to exercise independent judgment and discretion.
- Follow established safety and emergency response procedures.
- Work safely with potentially biohazardous biological specimens.
- Perform multiple tasks and establish priorities.
- Recognize own stress level and communicate need for assistance appropriately.
