Ability to stand in one spot for an extensive amount of time. Ability to lift surgical instrument trays. 	 Lengthy procedures that often require abstinence from nourishment and restroom breaks while standing in one confined area. Lifting heavy instrument caskets. Moving equipment. Transferring patients from stretcher to Operating Room (OR) bed and back.
Tactile Skills	Ability to assemble instruments/retractors.	 Passing instruments to multiple sterile personnel while holding retractor(s). Passing instrumentation and supplies to sterile team members.
